## COURSE OFFERED

LL. B. (Three Years)

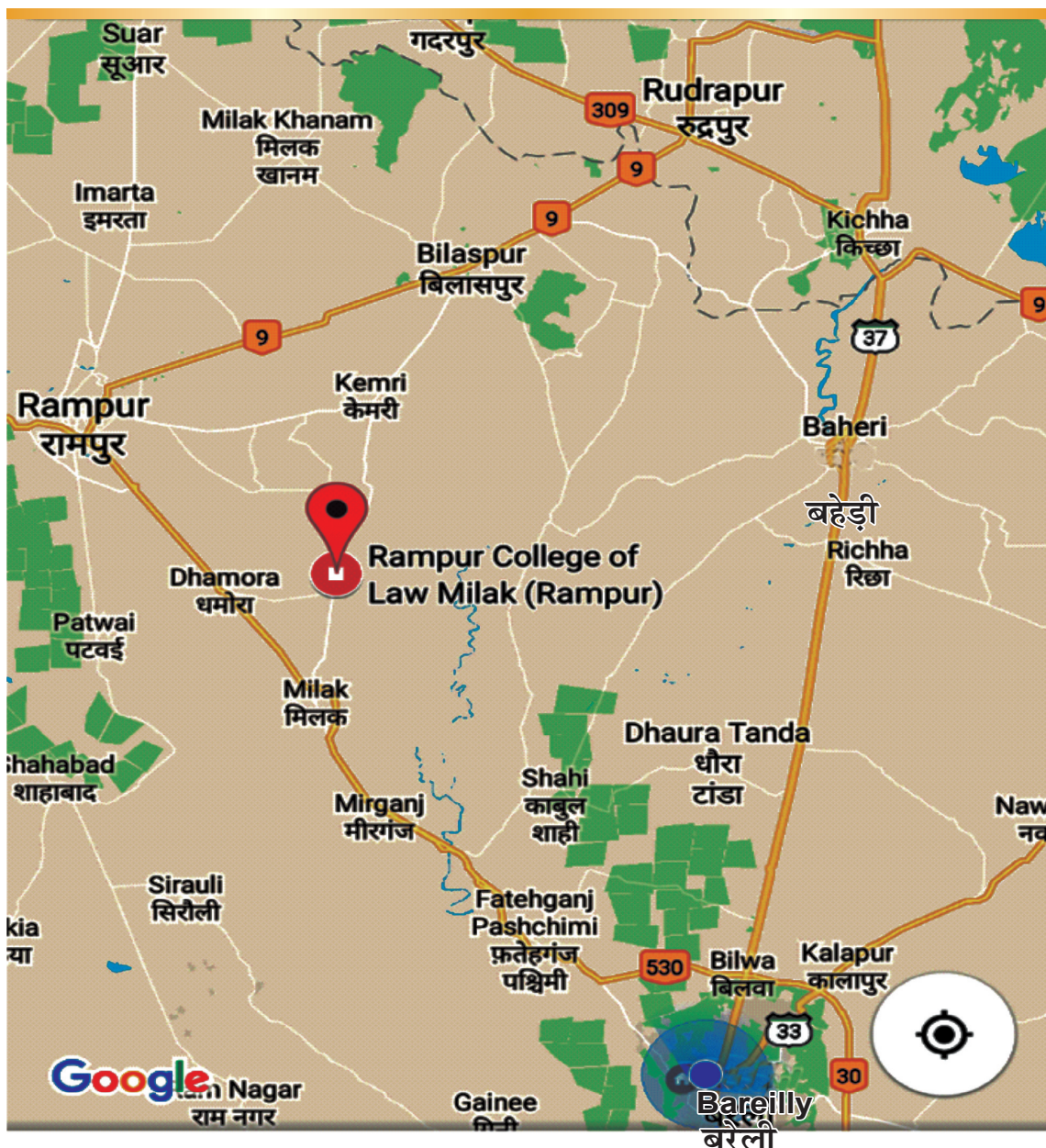
